- Owner can change dividend tracker that could be not audited and some functions may work in different ways.
- Total supply shows without zero addresses balance.

Owner privileges (In the period when the owner is not renounced)

- Owner can change gas for processing.
- Owner can change minimum tokens before sell.
- Owner can change supplySoldTriggerRate.
- Owner can change charity and marketing addresses.
- Owner can exclude from fee.
- Owner can manually call buybackAndBurn().
- Owner can change minimumTokenBalanceForDividends.
- Owner can update claimWait value.

Smart contracts do not contain high severity issues! Liquidity pair contract's security is not checked due to out of scope.

Liquidity locking details are **NOT** provided by the team.
